- Mighty mid conference report:
  - Focus on strategies for working with coaches and swimmers both on deck and on LSC board
    - Getting more people involved especially coaches
    - Making sure there is communication available to all.
    - Making sure committees were not done in a bubble and that coaches were involved with specific committees that affect their athletes the most.
      - Time standards
      - Camps
      - Meet selection
      - Overall direction of the LSC
  - o What are the responsibilities of the LSC to enhance coaches/swimmer's?
  - Should an LSC have goals for achievements of their athletes? Example how can we get X number of athletes qualified for the 2024 trials.
  - Is the LSC doing enough to develop athletes in the long term. The 12-14 year old's now are the next group for 2024 trials.
  - Select style camps are being done in many LSC's and are successful in developing young athletes.
  - Biggest concerns and difficulty for getting coaches on board is the poaching or recruitment of swimmers.
  - Biggest suggestion was that new coaches are chosen for these roles and not repeated. Work on getting more coaches involved in the planning and execution and make sure that coaches agree to a COC prior to attending. Might even consider not letting coaches whose swimmers are on the select teams be on the staff.
  - There was a general feeling throughout was that the LSC's do not support the coaches well with education opportunities, athlete support or a feeling of being able to participate in LSC governance.
