4d. Awards:

ii. Short course divisional meets: Awards other than ribbons will be ordered and provided by PNS. The PNS Office will notify the Meet Director of the procedure for obtaining ribbons prior to the meet.

iii. PNS format-series meets, including challenge and age group invitational meets: The PNS Office will notify the Meet Director of the procedure for obtaining PNS-specific awards prior to the meet. The meet host is responsible for paying for all awards described in the Meet Announcement.

Discussion as to why entry fees, specifically KCAC, were different for some meets. Explanation being Senior meets have few athletes than AG meets, and host teams must be able to cover the costs of KCAC with fewer meet entries.

• Per 2017 USAS Convention – housekeeping changes

By-Laws, Article 2 – Membership adding Flex Membership defined as "A Flex Athlete Member is an individual 18-years old or younger, who participates or competes in the sport of swimming and is in good standing as an individual member of PNS and USA Swimming."

- Year-Round membership
- LSC can choose to offer Flex Membership must opt-in be voted on at HOD.
- Can demote past swimmers at the beginning of registration year (cannot demote inside a year, but first registration each registration year can demote)
- \$20 fee (\$10 to PNS \$10 to USA-S)
- o Primary focus is 12&U
- o Only 18 & Under athletes.
- Upgradable to "Premium"
- Two sanctioned meets per year below championship meet level (PNS will decide what "championship" means—can be AGR.)
- Includes same insurance as Premium membership
- SWIMS is being upgraded to reflect changes.
- Meet recon will flag if two meets have been attended.
- Meet Times will not upload post meet if Flex athlete already has two meets in SWIMS. If they
- o upgrade post-meet, then the times can be uploaded.
- Definition of meet participation is only swimming at least one event 50 or longer. SWIMS does not recognize 25s so if a meet is all 25s then will not be counted as a meet.
- Observed and approved meets don't count in SWIMS as "Sanctioned."—swimmers can swim in approved and observed meets with no penalty

Discussion:

Not known if Team Unify add to their platform for registration, or if a Flex Membership will transfer from one LSC to another.

Clubs would have the option to offer to their member or not.
