Finance: Dave Baer - Report is online

- Review of financial books was done. All in good order. Outgoing treasurer, Audra Messagee-Evans, has done a great job. As does Colleen in helping maintain the books.
- Regarding upcoming vote on 2019-2020 Budget Proposal, note that historically we spend more than we take in an Olympic Year and cover that short fall in subsequent years.
- SplashForward, PNS has provided \$20K toward initial planning stage. Will assess level of support in future as the projects progresses.

Program Operations: Suzanne Rychlik

- Alignment process survey will be sent out early June, prioritize choices and write #1-7 for options.

- Leadership opportunities "She Leads Summit" sent two athletes
- Women's leadership conference. Sent 1 coach
- Leadership summit: reports from attendees
 - Athlete Kieran Watson (OCA) There was a personality test taken (not all people work alike). People were then
 put into groups and given scenarios to problem solve. Worked to achieve goals of group (as opposed to personal
 agendas). Found this a valuable and interesting summit. PNS should support in future.
 - Athlete Garcia Cuauhtemoc (MET) added that they were quizzed on what you value in life and does your behavior align with your values. Worked on strengths/weaknesses. Advocates for sending athletes to future leadership summits.
 - Coach Keith Freeman (OCA): People came together cohesively in a 3 day period that often does not happen over 3 months/longer. Interacted with others from all over the country but not competing against other "teams", so sharing was great and open. Encourage in our LSC Leadership forums, coach lunches/or skype with other coaches and learn from other's ideas. Good to learn how others are Interacting with parents and athletes alike.

- Athlete committee it's been challenging to get people together to have meetings.
- In 2018, PNS sent 4 athletes to convention, as opposed to 2 as in previous years. Convention applications due May 20 for 2019 Convention.

 swimming. The award is sponsored by Swimming World magazine and Hasty Awards. This award is being presented to
 Lisa Vetterlein.

Safe Sport/Risk Management:

- Per USA Swimming Article 306.1 [pg. 97]
 - "It is every member's responsibility to promptly report any incident regarding sexual misconduct...to the US Center for Safe Sport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party."
- Further, the Washington State "Protecting Young Victims from Sexual Abuse and Safe Sport Authorization Act of 2017" (aka "End Harm Act"):
 - Requires any person in an official supervisory capacity (e.g., USA Swimming and its adult members) to report suspected child abuse, including sexual abuse, to local or federal law enforcement or to a child-welfare agency WITHIN 48 HOURS
 - A failure to report is subject to criminal penalties!
 - If you see something, say/report something...but DO NOT investigate

- j. A properly completed and signed PNS Master Entry Summary and check for entry fees are due to the clerk of course no later than when the team checks in.
- k. RECORDING DEVICES & MEDIA NOTICE: In compliance with USA Swimming Rules and Regulations: The use of audio-visual recording devices, including cell phones, are not permitted in locker rooms, changing areas or restrooms. Recording devices (cell phones, cameras, PDA's, etc.) are not permitted behind the starting blocks during the entire meet. This meet may be covered by the media, and/or Professional photographer taking photographs, video, web casting and other forms of obtaining images of athletes participating in the meet. Entry into the meet is acknowledgement and consent to this fact. Photographers should have visible credentials and background checks prior to arrival on deck and with Meet Director approval, Photographers may have access to the pool deck and must abide by USA Swimming and facility camera/photograph restrictions. In the event of any disputes regarding video recording, the Referee's decision shall be final and binding.

1. Meet Entry Eligibility

b.

- o vi. Clubs with a Flex member athlete who is shown to have competed in their third meet will be notified that the athlete in guestion will be upgraded to a full membership. Teams will need to submit the balance of the full membership.
- o vii. The registration charges and fines resulting from the above paragraphs are due to the PNS Office prior to the entry deadline of the next meet entered by the team being fined or within fifteen (15) business days after receipt of the fine statement, whichever occurs first.
- viii. Teams and affected individual athletes will not be considered to be in good standing with PNS until all of the above fines and registration fees are paid and as such, they will not be allowed to participate in any PNS related activities until this condition is rectified.
- ix. All of the above apply to the athlete's parent (or to the athlete if the athlete is age 18 or older) if a Master Entry Summary and/or a Deck Entry Registration form is signed independently of a club.

- 2. Individual Member Registration
 - a. Athlete Members/Flex Members/Seasonal Athlete Members
 - i. All swimmers participating in sanctioned activities (including club practices and workouts) must be registered athlete members of USA Swimming. The year-round membership period for renewal is from January1 to December 31 of the following year. The year-round membership period for new membership is September 1 to December 31 of the following year. Flex membership period is September 1 to December 31 of the following year. Flex memberships are only permitted to participate in two meets each season that may not include LSC Championship or higher meets. Seasonal registration is offered twice each year. Season I is from September 4 to January 31. Season II is from April 1 to August 28.
