X.X.X USA Swimming Life Member

A Life Member is an individual who is a member of USA Swimming and who resides, formerly resided or participated in the sport of swimming in the geographic territory of Pacific Northwest Swimming and who is in good standing as a member of Pacific Northwest Swimming and USA Swimming. The LSC may choose to award one Life Membership annually to a member who has been a member of the Pacific Northwest Swimming LSC for a minimum of 10 years. Prospective nominees must hold or have held a leadership position within Pacific Northwest Swimming as a member of the Board of Directors, active committee member, or other such position as deemed appropriate by the Board of Directors. Award nominations will be solicited at a time determined by the Board of Directors.
