### APPROVAL OF MINUTES

A motion was made, seconded, and voted upon to approve the September 26, 2022, BOD minutes as posted.

### **OFFICERS REPORTS**

Treasurer/Finance: Report attached

- The stock market is down
- The switch to SWIMS 3.0 has caused about a 30-day lag in our receipt of registration revenues, and many clubs appear to be waiting until year-end to renew.
- Registration numbers are still low, likely due to SWIMS 3.0's complexities.
- Not all expenses have been booked: DEI athlete support, Zone coach payments

Membership: Report attached - only 16 of our 42 member clubs have renewed

Officials Report: Officials training clinics so far this year should give us 158 new Stroke & Turn and Administrative Officials. Referees have been selected for both December championship meets which will be Officials Qualifying Meets offering N2 certification.

### Age Group:

- All-Star applications are due December 15
- A marketing committee is looking into an athletes' camp
- Everyone is welcome to submit designs for the summer 2023 Zones team items

Senior: No report

Program Operations: Suzanne unable to attend. John S: The November AGI meets were all undersubscribed so an additional bonus opportunity was added; changing the time standards would not have been practical on such short notice.

Program Development: No report

Administrative Vice-Chair: The change of the 120-day transfer window to 60-days will require changes in PNS policies citing that rule. The Sanction Chair said that our policy regarding an unregistered swimmer competing at a meet will have to be also require a change to reflect SWIMS 3.0.

Athlete Report: They are looking into a high performance training camp. Ken said that's been done in past Olympic years so the model exists.

Coach Report: Looking into coaches clinics: ASCA? High school coaches?

Safe Sport Report: Looking into an in-person coach & club board president seminar in the new year; USA Swimming would send someone out to lead it.

Diversity: No report.

#### **OLD BUSINESS**

#### AD 97-05 Travel Reimbursement:

Ken: We do not have sufficient funds to continue the current program. It will be necessary to limit payments to Futures and above, excluding Sectionals and Zones, perhaps with a lump-sum amount per meet that would be divided among the athletes. The reimbursement application time window will probably be shortened.

David: The new officials policy should be out soon.

### **NEW BUSINESS**

#### Hall of Fame

Bob: We have not held a HOF Induction Ceremony since 2012, but five individuals were named in 2020. It was moved, seconded, and approved to approve funding (See attached proposal.) for a ceremony during next summer's long course champs. The senior meet might be the best in terms of national meet conflicts. A December 2022 date might not provide enough notice to honorees, and winter travel is always an issue.

- The PNS HOF recognizes athletes, coaches, and contributors.
- It is possible that additional individuals could be recognized by next summer.

#### Senior Funding

Ken: Should senior funding be need-based or performance-based? It is currently performance-based, it is highly likely that most parents would send their athletes to high-level meets independently of funding. Additional information is attached.

### **Finance Report:**



The value of our reserve account held in our Fidelity stock market account has dropped as the broader stock market has declined. The PNS balance sheet is attached.
















