- Jimmy Flowers Classic (1st weekend of June): teams that have athletes that wish to compete and are not yet classified will need to go a day early (disability must be classified before competition).

USA swimming Liaison Reports – Ron VanPool, Dave Coddington (Ron at the Safe Sport Workshop)

- Western Zone workshop will be April 28 & 29 in Scottsdale, AZ. 6 representatives are expected from each LSC: General Chair, Safe Sport, Official Evaluator (N3), Registrar, *Times Person*, and athlete representative. The potential to add persons from the LSC depends upon space.
- Chuck Wielgus announced his retirement effective in August time frame to find new Executive Director and help with the transition.
- WADA (World anti-doping agency) discussing out how to deal with a country and any responsibility for the doping of their athletes.
 - The USA National Team is writing to FINA and WADA to emphasize their determination to make Swimming a Clean Sport.
