Swimposium:

USA will help fund an LSC hosting a swimposium every 3 years.

Locations have been reserved for two dates, May 13th which is PNS HOD, and Sept. 30th. Discussion about the two date format, the first being education oriented, and the latter being swimmer /parent oriented. Concern that adding swimposium piece to May 13th date (day before Mother's Day) would not support it being well attended. Decision was to provide both tracks on September 30th. These tracks would include: BOD, Coach, Athletes, Parents, and Officials. Some discussion about adding in an awards banquet. Point made that when we add an awards banquet, we need to commit to it long term, not a one time only event.
